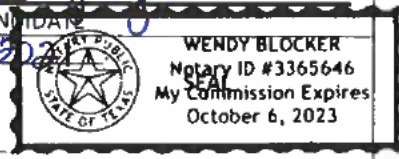
Before me, the undersigned authority, on this day personally appeared (name) Tanya Easterling Gregory, who being by me here and now duly sworn, upon oath says:
